Public Comment:

Jean Anderson read an excerpt of the 2009 Master Plan for Schoolcraft County signed by the Board of Commissioners.

Kim Fannin thanked the Board of Commissioners for the Appointment of Corey Barr to the Housing Commission Board and their support.

Marilyn Benish thanked the Board of Commissioners for their hard work and stated she will miss Commissioner Allen Grimm and Commissioner Gerald Zellar after the end of the year and hopefully Commissioner Daniel LaFoille succeeds with re-election.

John Norrington, Schoolcraft County Sheriff and 911 Administrator, stated that he had went to the City Council Meeting and that the City agreed to a 100 ft. tower with a unanimous aye vote from that board. The building permit is filled out and in Jake Rivard's office.

Beth Edwards, County Clerk, stated that the Board of Commissioners voted to move the second submit for HRA claims from Kushner to Employee Benefits Agency effective December 1, 2014, however, after talking with Vince Babcock, Employee Benefits Agency, it would make more sense for the switch to be on January 1, 2015 to coincide with the new year deductible and Kushner is also paid through the end of the year.
