

## **SCHOOLCRAFT COUNTY BOARD OF COMMISSIONERS**

The Schoolcraft County Board of Commissioners met for the Annual Organizational Meeting on Thursday, January 2, 2014, in the District Court Room of the Schoolcraft County Building, City of Manistique, Michigan, commencing at 4:00 P.M. Chairperson Allen Grimm called the meeting to order. The roll was called with the following members present and/or absent:

The motion carried by unanimous aye vote of the Board.

Public Comment: Commissioner Reiter said he will talk to the Road Commission about helping plow the Airport when needed.

It was moved by Commissioner Zellar and was seconded by Commissioner Cameron to adjourn the Organizational Meeting of the Schoolcraft County Board of Commissioners. The motion carried by unanimous aye vote of the Board. The meeting was adjourned at 4:12 P.M.
