The purpose of this special meeting is to discuss an access easement, discuss an operator agreement, present the tentative special assessment district boundaries to the public, answer questions, conduct any applicable administrative tasks (e.g., pay bills), and address any matter that may come before the Lake Authority.

Proceedings conducted at this special meeting will be subject to the provisions of the Michigan Open Meetings Act. Public Meeting re: Lake Level Special Assessment District

- Schoolcraft County is in the process of establishing a **lake level special assessment district** for all three of its legal lake levels, including Gulliver Lake
 - The Schoolcraft County Board of Commissioners appointed the Gulliver Lake
 Authority as the delegated authority to maintain the legal level of Gulliver Lake,
 including establishing a special assessment district
 - The Gulliver Lake Authority includes representatives from Schoolcraft County and Doyle Township
- A special assessment district will provide a consistent funding mechanism to help ensure Gulliver Lake can be maintained at its legally established level
 - Boundaries of the proposed special assessment district will include properties with private legal access to the lake (lakefront, deeded, platted, etc.)
 - Your property is currently under consideration for inclusion in the special assessment district
