#### **Reconvened Hearing to Amend Lake Level Order**

A petition dated May 30, 2024 was filed with the Schoolcraft County Circuit Court to amend the lake level order for McDonald Lake. The Schoolcraft County Circuit Court held a hearing on July 11, 2024 to review the petition and receive evidence to amend the lake level order for McDonald Lake, located in Doyle and Mueller Townships, Schoolcraft County, Michigan, consistent with the provisions of MCL 324.30707. Following the July 11 hearing, the Court set a reconvened hearing on the above date, time, and location to receive additional evidence to confirm the boundaries of a lake level special assessment district for McDonald Lake.

#### **Submitting Testimony and Evidence**

The public may submit written testimony and provide evidence regarding the lake level special assessment district boundaries to the Court. The public may also attend the hearing at the above date, time, and location to provide oral testimony and/or evidence.
