NOTICE OF INTENT TO PREPARE A MATERIALS MANAGEMENT PLAN

To the residents and property owners of Schoolcraft County and any other interested persons: PLEASE TAKE NOTICE that the Schoolcraft County Board of Commissioners has submitted a Notice of Intent to Prepare a Materials Management Plan to the Department of Environment, Great Lakes, and Energy and will act as the County Approval Agency for such Plan. This Notice of Intent was submitted jointly to prepare a multicounty Materials Management Plan encompassing Alger, Delta, Dickinson, Marquette, Menominee, and Schoolcraft Counties. The Schoolcraft County Board of Commissioners will approve the resulting Materials Management Plan prior to the approval of local units of government.

The submission confirms the establishment under Part 115 of the Michigan Natural Resources and Environmental Protection Act of the Central Upper Peninsula Materials Management Planning Committee, a joint body of representatives with responsibility for the creation of a Materials Management Plan regulating solid waste disposal, recycling, and composting activities within the planning area. Regular meetings, subject to Part 115 and Open Meetings Act requirements, will be held by this Committee; persons interested in attending may request notification of upcoming meetings and anticipated subject matter.
